NOTICE OF CERTAIN SIGNIFICANT EVENTS - RATING CHANGES

THIS NOTICE OF CERTAIN SIGNIFICANT EVENTS – RATING CHANGES, dated December 5, 2017 (the “Notice”) has been prepared to satisfy the obligations of the County of Orange, a political subdivision of the State of California (the “County”) with respect to the County of Orange Taxable Refunding Pension Obligation Bonds, Series 1997A (the “1997A Bonds”) and the Orange County Public Financing Authority Lease Revenue Bonds, Series 2006 (the “2006 Bonds”).

NOTICE IS HEREBY GIVEN that on December 1, 2017, S&P Global Ratings (“S&P”) withdrew its rating on National Public Finance Guarantee Corp. (“National”), the current financial guaranty insurer for the 1997A Bonds and the 2006 Bonds. As a result of the withdrawal, there is currently no S&P insured rating on the 1997A Bonds, and the S&P insured rating on the 2006 Bonds reflects the S&P underlying rating on the 2006 Bonds of “AA”.

This Notice has been prepared to satisfy the obligations of the County pursuant to the respective Continuing Disclosure Certificates (the “Disclosure Certificates”), executed and delivered in connection with the issuance of the 1997A Bonds and the 2006 Bonds, and the requirements of Rule 15c2-12 of the Securities Exchange Act of 1934, as amended. As provided in the Disclosure Certificates, this Notice being prepared for publication with the Electronic Municipal Market Access, a service of the Municipal Securities Rulemaking Board. All capitalized terms used herein shall have the meanings set forth in the Disclosure Certificates.

CERTAIN DISCLAIMERS

The ratings actions described in this Notice express only the views of the applicable rating agency. An explanation of the significance of any such rating may be obtained from the applicable rating agency; provided, however, that no information provided by any rating agency is incorporated in this Notice. Actions of a rating agency are not a recommendation to buy, sell or hold any Bonds. There is no assurance that any rating on any Bond will remain in effect for any given period of time or that they will not be revised, either downward or upward, or withdrawn entirely by a rating agency if, in its judgment, circumstances so warrant. The County and the Orange County Public Financing Authority (the "OCPFA") undertake no responsibility to oppose any revision or withdrawal of such ratings. Any such downward revision or withdrawal of such ratings may have an adverse effect on the market price of the Bonds.

To the extent the County and the OCPFA provides information in this Notice, the County and the OCPFA are not obligated to present or update such information in future notices or reports. Investors are advised to refer to the applicable Official Statements for the Bonds for information concerning the initial issuance of and security for the Bonds.

By providing the information in this Notice, the County and the OCPFA do not imply or represent (a) that all information provided in this Notice is material to investors' decisions regarding investment in the Bonds, (b) the completeness or accuracy of any financial, operational or other information not included herein or in the Official Statements, (c) that no changes, circumstances or events have occurred since the date of this Notice (other than as contained herein), or (d) that no other information exists which may have a bearing on the County's and the OCPFA's financial condition, the security for the Bonds or an investor's decision to buy, sell or hold the Bonds.

The information set forth in this Notice or incorporated in this Notice has been furnished by the County and the OCPFA and is believed to be accurate and reliable but is not guaranteed as to accuracy or completeness.
